### **Nurses for Single Payer elects 2019 Board**

In May, a fabulous new slate of leaders were elected: President Carole Most, VP J.R. McLain, Treasurer Tom Sincic, Secretary Robin Tarter, and Board Members Betsy Zucker, David Young, Kathy Birch, Lea Wilcox-Sanders, Maureen Andersen, Nancy Sullivan, and Rachel Prusak. ### **Update on Single Payer Legislation**

- In Oregon, SB770A would create a funded task force to design a state-based single payer system. If this passes, it will be a milestone in moving toward asingle payer, universal health care plan in Oregon. This bill has more support than any prior Oregon single payer bill. By the end of June, we'll know if it has passed into law!
- In Congress, there are two bills to create national single payer systems, S.1129 (Bernie Sanders' Medicare for All Act) and HR 1384, (Rep. Jayapal's Medicare for All Act of 2019). Neither will pass with a Republican Senate, but the House Bill has been reviewed in three first-ever Congressional hearings this year, most recently in the Ways and Means Committee on June 12. This is more evidence for the growing support for Medicare for All in Congress and throughout the country. Rep. Blumenauer is a strong supporter of the bill and he and others spoke at a press conference after the hearing.
