Oregon's SB 770 Passes!

In a big victory for the single payer movement, SB 770 passed! The bill, championed by Sen. James Manning of Eugene and strongly supported by Health Care for All Oregon, creates a Task Force to develop a fully-fleshed out single payer health care plan for all Oregonians. Members of the Task Force will be appointed and begin work in 2020, and report back to the legislature in 2021.

Organize in Rep. Schrader's District

Rep. Kurt Schrader represents the 5th Congressional District. He is the only Oregon Democratic member of the House of Representatives who has not yet co-sponsored the Medicare for All Act of 2019. Attend one of these upcoming exciting events to help change that!

National Medicare for All Update

Medicare for All continues to gain support nationally, even as the future of the ACA remains in the courts. There are Medicare for All bills in both the Senate (S. 1129) and the House (HR 1384). The House held several hearings on Medicare for All this spring - a historic first! Rep. Jayapal of Seattle is the chief sponsor. Of Oregon's Democratic delegation, only **Sen. Wyden** and **Rep. Schrader** have NOT co-sponsored Medicare for All. Let them know what you think about that.
